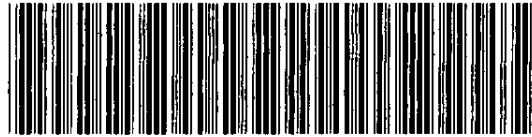



ARTICLE I

NAME

PURPOSES

TERMINATION OF MEMBERSHIP




