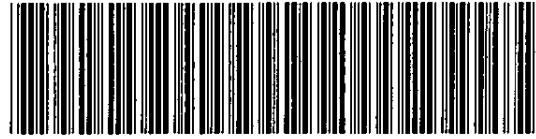

**Instructions for Reservation of LLC Name Letter**

The name of a Florida LLC must end with the words "Limited Liability Company" or "Limited Company" or the abbreviation "LLC," "LC," "L.L.C.," or "L.C." The word "limited" may be abbreviated as "Ltd.,"; the word "Company" may be abbreviated as "Co."

You cannot reserve names for use by LLCs (and other business entities). You can make a preliminary name availability request over the phone by calling the state LLC Filing Office. You can also search name availability at the Division's web site. Once you have determined that a name is available, quickly file your Articles (online filing is quicker than filing by mail). If you file by mail and the name is not available, you will be notified by the filing office.

The mailing address of your state's LLC filing office is inserted by LLC Maker in the heading to the reservation letter. The person whose name is shown at the bottom of the letter should sign it, and include a stamped, self-addressed envelope for reply by the state LLC office. Make sure to include payment for the fee with your reservation letter. Make the check payable to the name of the state LLC office shown in the heading of the letter.






