ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS

The name of this limited liability company shall be **PK Studios Interior Design, LLC** (the "Company"). The mailing address and street address of the principal office of the Company is 2550 Goodlette Frank Road, Unit 1, Naples, Florida 34103.

ARTICLE II

DURATION


