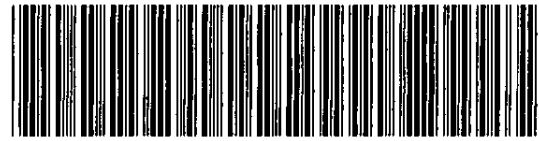




**ARTICLES VIII**



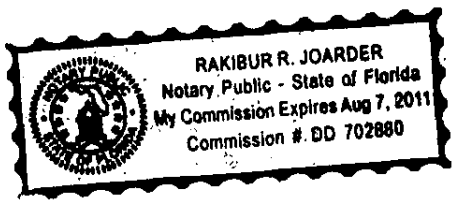
