The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE I -- NAME**

The name of the limited liability company shall be INTERIORS BY STEPHEN PAUL, L.L.C.

#### **ARTICLE II -- ADDRESS**

The mailing address of the principal office is P.O. Box 6798, Ocala, Florida 34478 and the street address of the principal office of the limited liability company is 923 NE 42<sup>nd</sup> Terrace, Ocala, Florida 34470.

#### ARTICLE III – PURPOSE

#### ARTICLE VI — INITIAL AND ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make initial capital contributions in cash, services and/or property, however, each member shall continue to make additional capital contributions to the limited liability company only as determined by the majority capital interest holders who are entitled to vote, or as otherwise provided in the Operating Agreement including any amendments thereto.

#### ARTICLE VII -- ADMISSION OF NEW MEMBERS

#### ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall not be dissolved on the death, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless otherwise stated in the Operating Agreement, and only by a unanimous vote of the remaining members.

#### ARTICLE IX -- MANAGEMENT

The limited liability company shall be initially managed by Stephen Paul Popowich and shall continue to be managed by that member unless otherwise mandated in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the company.
