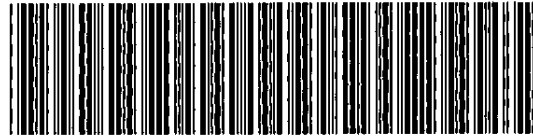

(Right to Continue Business)






