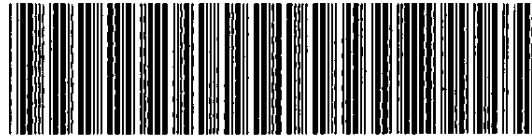

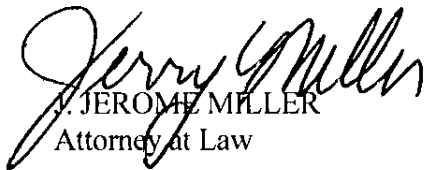

ARTICLES OF ORGANIZATION
OF
R B M CONTRACTING SERVICES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F. S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be R B M CONTRACTING SERVICES, LLC, (“Company”).

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company shall be:

Santa Rosa Beach, Florida 32459

ARTICLE III – DURATION

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Company’s existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV – REGISTERED OFFICE

The name of the registered agent and the street address of the registered agent of the Company in the State of Florida is Branch McClendon, 285 Lynn Drive, Santa Rosa Beach, Florida 32459.

ARTICLE V – CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company the cash or property described in the Operating Agreement for the Company.

ARTICLE VI – ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except as described in the Operating Agreement for the Company.

ARTICLE VII – TRANSFER OF INTEREST

A member may not transfer his or her interest in the Company except as described in the Operating Agreement of the Company.

ARTICLE VIII – TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of a majority of the sharing ratios of all the remaining members.


ARTICLE IX – MANAGEMENT

The Company shall be managed by the members in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The name and address of the initial member who is responsible for the management of the Company is Branch McClendon.

ARTICLE X – AMENDMENT

These Articles of Organization may be amended as provided in the Operating Agreement for the Company.
