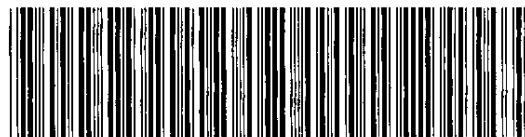

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF GREEN ENERGY
CONCEPTS, L.L.C., A FLORIDA LIMITED LIABILITY COMPANY
