ARTICLES OF DISSOLUTION

OF

THREE SISTERS SPRINGS HOLDING THREE, LLC

Pursuant to Section 608.441(1)(b), Florida Statutes, Three Sisters Springs Holding Three, LLC, a Florida limited liability company (the "LLC") submits the following Articles of Dissolution:

1. The name of the LLC as currently filed with the Florida Department of State is Three Sisters Springs Holding, LLC.
2. The LLC's Articles of Organization were filed on September 11, 2008 and assigned document number L08000086491.
