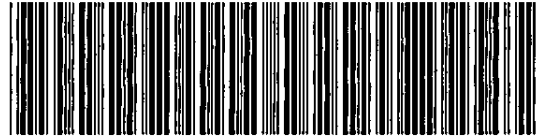


**Article VI**
