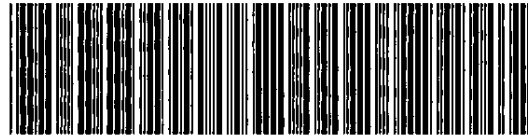

**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF ORGANIZATION  
OF SAJUNE MEDICAL CENTER, L.L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida company hereby adopts the following Articles of Amendment to its Articles of Organization:

Article I - Name and Date of Filing

The name of the company is SAJUNE MEDICAL CENTER, L.L.C. (hereinafter referred to as the "Company"). The Articles of Organization of Company were originally filed on September 8, 2008. The Company's Florida document number is L08000087292.

Article II - Adoption and Text of Amendments
