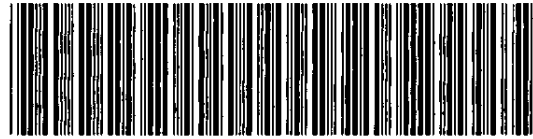

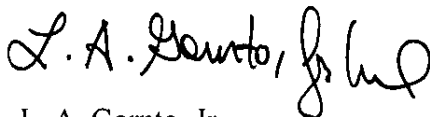

NAME

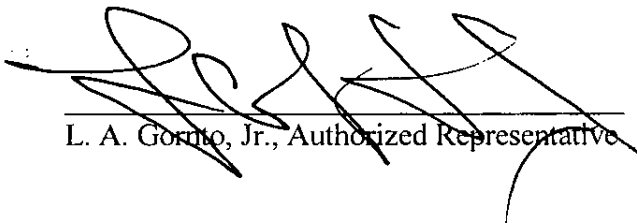

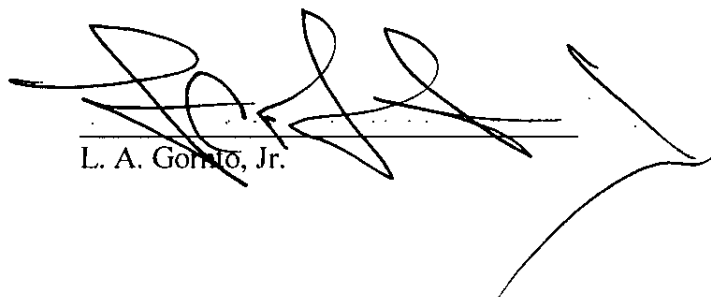
