**ARTICLE IV: PURPOSE**

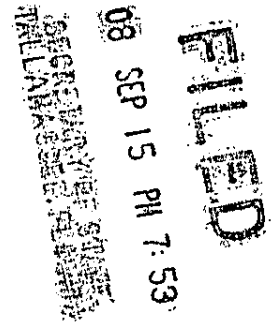
To conduct any and all lawful business in the United States and abroad.


