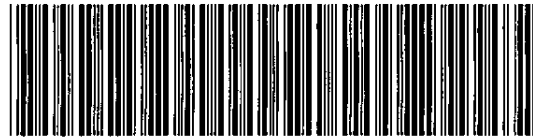

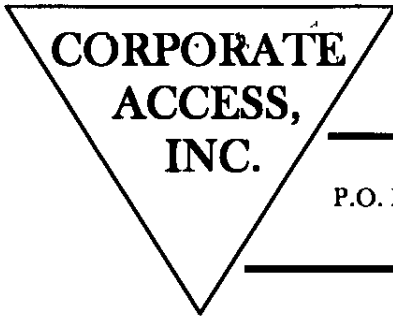

PURPOSE AND POWERS**


The Company is organized with a general business purpose, has all powers provided by law and may use those powers to any lawful purpose.


