**ARTICLES OF ORGANIZATION OF
KMJ BUSINESS GROUP, L.L.C.**

**ARTICLE I
NAME**

The name of this Limited Liability Company shall be: KMJ BUSINESS GROUP, L.L.C.

The power to alter, amend or repeal these regulations shall be vested in all the members of this company.

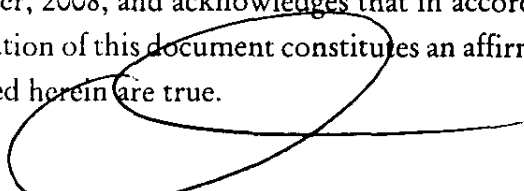
ARTICLE VI

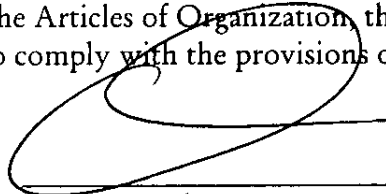
