
ARTICLE VI



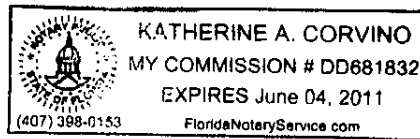


