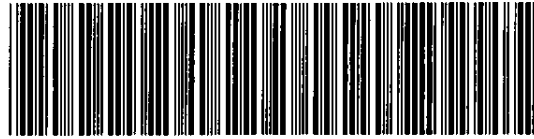

NAME


