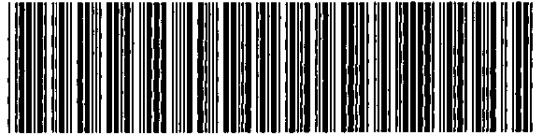

The regulations of this company may only be adopted, amended, altered or repealed by unanimous decision of the two managers of the company in a meeting called to that effect.

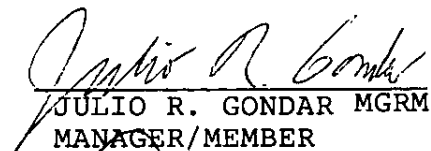
ARTICLE IX-MEMBERS' RIGHT TO CONTINUE BUSINESS

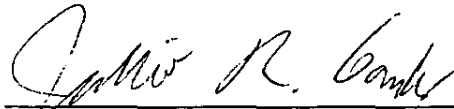
