The principal address and mailing address of the Company is 7777 Glades Road, Suite 204, Boca Raton, FL 33434.

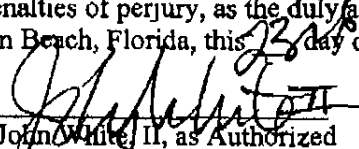
ARTICLE III. REGISTERED OFFICE AND AGENT
