Principal Office

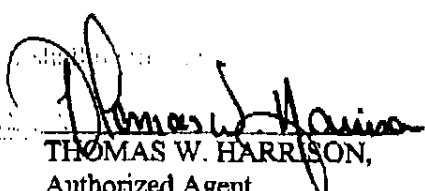
