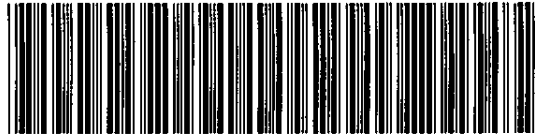

SECOND: The Articles of Organization were originally filed on September 23, 2008.


THIRD: Article V is amended is amended to provide that the limited liability company shall be managed by a Manager whose name and address are set forth below:
