Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

FIRST: The name and address of this corporation is **CROWN ENTERPRISES LLC**, 18026 Arbor Crest Drive, Tampa, Florida 33647.

SECOND: The date of the adoption of these Articles of Dissolution is 24 August 2009.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests. The amendment was unanimously approved in writing by all members.
