# ARTICLES OF ORGANIZATION OF HUDDLESTON-JAGDFELD, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

## ARTICLE I - NAME
