ADDRESS**

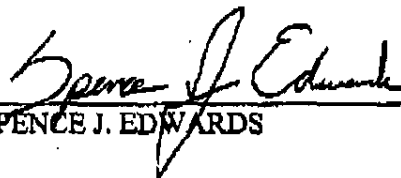
