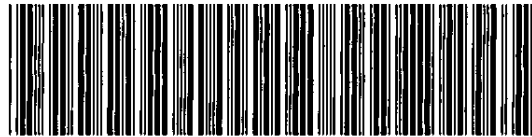

**1. NAME.** The name of this limited liability company is 139 Ventures, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

**2. PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 218 East Bearss Avenue, Suite 409, Tampa, Florida 33602.


