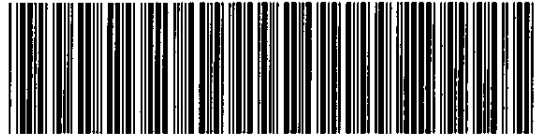




ARTICLE V
