ARTICLES OF ORGANIZATION OF LAGO OAKS INVESTMENT, LLC

This Amended and Restated Articles of Organization is made and executed this **22** day of May, 2015, by the undersigned persons and amends and restates the Articles of Organization that were originally filed on September 24, 2008 under the laws of the State of Florida.

- 1. Name. The name of the limited liability company is Lago Oaks Investment, LLC (the "LLC").
- 2. <u>Principal Office</u>. The street and mailing address of the LLC's principal office is: 405 S Dale Mabry Hwy, Suite 128, Tampa Florida 33609.
- 3. Registered Agent. The name of the LLC's registered agent is Preston O. Cockey Jr.; the address of such agent is 110 E Madison, Suite 204, Tampa, Florida 33602.

Having been named as registered agent and to accept service of process for the LLC at the place designated in these Articles, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 605 of Florida Statutes.

- 4. The Managers of the limited liability company are Basil N. Scaglione and Megan T. Scaglione.
- 5. <u>Transfers</u>. All member interests in the LLC, whether held by a member or by a transfer of an assignable interest, shall be subject to the restrictions, limitations, and options contained in the Operating Agreement of the LLC relating to the transfer of member interests, and no such membership or transferable interest shall be transferred except in accordance with the Operating Agreement. All persons are notified that the Operating Agreement restricts transfers and forbids any such transfer except in accordance with its terms.
- 6. Operating Agreement. The rights and obligations under the Operating Agreement are inherent characteristics of the LLC and of any membership interest, transferable interest, or other interest in the LLC, to which rights and obligations any person obtaining rights relating to the LLC or an interest in or relating to the LLC shall be subject. The Operating Agreement includes, among other things: provisions relating to transfer restrictions; rights of members, assignees, and transferces; and other matters.
