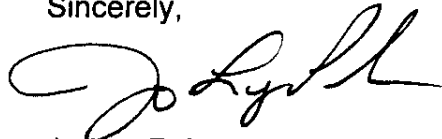

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

Name and Principal Place of Business

The name of the limited liability company shall be **BOB Family Properties, LLC** (hereinafter the "Company"). The mailing address and the street address of the principal office of the Company shall be 6320 Glasgow Drive, Tallahassee, Florida 32312.

ARTICLE II

Duration
