ARTICLES OF DISSOLUTION OF KJD GROUP LLC

- THIRD:** The date of the adoption of these Articles of Dissolution is 19 May 2022.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
