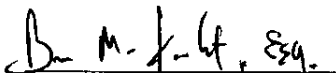

ARTICLES OF ORGANIZATION

OF

MOSBAH CHEHAB, M.D., P.L.L.C.

The undersigned subscribes to these Articles of Organization to form a professional limited liability company pursuant to the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) and the Professional Services Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes), providing for the formation, rights, privileges, and immunities of professional limited liability companies for profit. The undersigned further declares that the following Articles of Organization shall serve as the Charter and authority for the Company to conduct the business of the professional limited liability company.

ARTICLE I

NAME

The name of the professional limited liability company is MOSBAH CHEHAB, M.D., P.L.L.C. (the "Company").

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

The street address of the principal place of business of the Company and the mailing address of the Company is: 9700 SW 114 Street, Miami, Florida 33176, in the county of Miami-Dade, but the Company shall have the power of authority to establish branch offices at any other place or places as the member(s) may designate.

ARTICLE III

PURPOSES AND POWERS

In addition to the powers authorized by the laws of the State of Florida for professional limited liability companies, the general nature of business or businesses to be transacted, and which the Company is authorized to transact, shall be as follows:

1. To engage in every phase and aspect of business of rendering the same professional services to the public that a physician / medical doctor, licensed under the laws of the State of Florida to practice medicine, is allowed to render; provided that such professional services shall be rendered only through those corporate officers, employees, and agents who are duly licensed or otherwise legally authorized within the State of Florida to practice within the State of Florida; provided, further, that nothing herein contained shall be deemed to prevent the

Company from employing unlicensed persons in capacities in which they will not render such professional services to the public in the course of their employment.

2. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things set forth in these Articles to the same extent as a natural person might or could do.

3. To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the business, good will, rights, assets, and liabilities of any person, firm, association, or corporation carrying on any kind of business of a similar nature to that which this professional limited liability company is authorized to carry on, pursuant to the provisions of these Articles; and to hold, utilize, and in any manner dispose of the rights and property as acquired.

4. The Company may also engage in any other activities not specifically prohibited to a Profession Limited Liability Company, under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) or the Professional Services Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes), and shall also have the power to do all things necessary and proper to enable it to render such professional services, and to engage in such activities, including, but not limited to, the powers enumerated in the above referenced Acts or any amendments thereto, respectively, insofar as such powers do not conflict with the laws of the United States or the State of Florida.

ARTICLE IV

EXERCISE OF POWERS

All professional limited liability company powers shall be exercised by or under the authority of, and the business and affairs the Company shall be managed under the direction of, the member(s) of, the Company. This Article may be amended from time to time in accordance with the Operating Agreement of the Company by a majority vote of the members of the Company.

ARTICLE V

MANAGEMENT

This professional limited liability company is to be initially managed by one or more Managing Members. The name and address of the initial Managing Member is as follows:

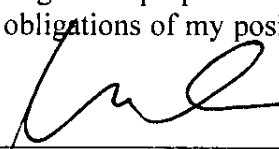

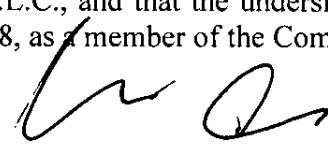
