The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

- 1. <u>Name.</u> The name of the limited liability company is 39 LAKE PARK CIRCLE, LLC (hereinafter referred to as the "Company").
- 2. <u>Period of Duration.</u> The period of duration of the Company shall be from the date of filing of these Articles of Organization until the mutual written agreement of a majority in capital interest of the members.
- 3. **Purpose.** The purpose for which the Company is organized is to engage in and any and all business activities permitted by the Act and any other applicable laws of the State of Florida.
