# ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

## **ARTICLE 1 - NAME**

The name of the limited liability company shall be **INTERNATIONAL REC** LLC, ("Company").

### **ARTICLE 2 - ADDRESS**

#### **ARTICLE 10 - INDEMNIFICATION**

If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable at extra expensions remaining shall not be otherwise affected.
