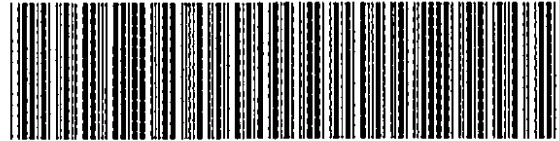

existence of the LLC and it is therefore being dissolved by unanimous vote of the members.

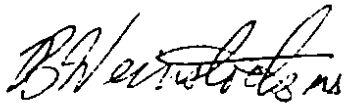
