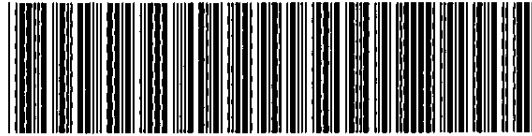


ARTICLE IV – MANAGEMENT




