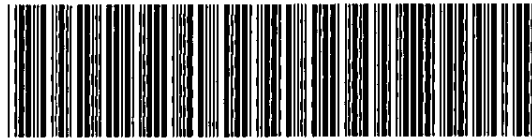




These Articles of Organization may be amended upon the affirmative vote of all of the Company's Class A Members and a majority of the Board of Governors.
