# ARTICLES OF ORGANIZATION

#### J & K TRUCKING OF PALM BAY, LLC

The undersigned persons hereby adopt these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

#### ARTICLE I – NAME
