# ARTICLES OF ORGANIZATION OF NM DEVELOPMENT GROUP, LLC,

a Florida Limited Liability Company

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

#### ARTICLE I NAME

The name of the limited liability company is **NM DEVELOPMENT GROUP, LLC**, a Florida limited liability company (the "Company").

## ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be 9130 Galleria Court, Suite 316, Naples, Florida 34109-4418.

Newly admitted members shall have all of the rights and privileges as set forth in the Company's Operating Agreement and Regulations.

#### ARTICLE V EFFECTIVE DATE

The Company's effective date of existence shall begin on the date of filing of these Articles.

#### ARTICLE VI DURATION

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company as provided in the Operating Agreement and Regulations.

### ARTICLE VII ADOPTION OF OPERATING AGREEMENT AND REGULATIONS

The Company will be managed by a manager or managers, who shall be designated, appointed or elected as more fully described in the Operating Agreement and Regulations. Initially, the number of managers of the Company shall be two (2). The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations.
