Article III. Amendment

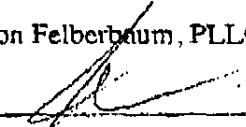

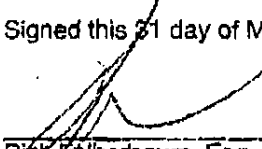
