ARTICLES OF ORGANIZATION OF CINDY RAY INTERIORS FOUR, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company is CINDY RAY INTERIORS FOUR, LLC. (the "Company").

ARTICLE VII - Admission of New Members
