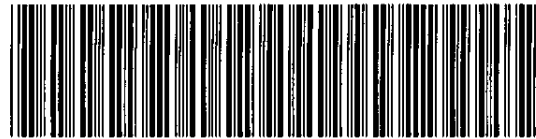


ARTICLE VI


