ARTICLES OF ORGANIZATION

ARTICLE I -- NAME

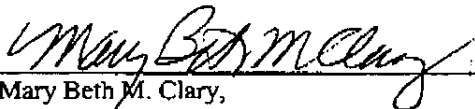
ARTICLE IV -- REGISTERED OFFICE AND AGENT

IN WITNESS WHEREOF, the undersigned organizer has made and subscribed these Articles of Organization at Naples, Florida, on this 7th day of October, 2008.

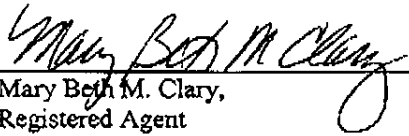
