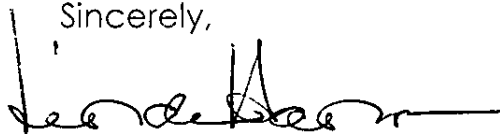

**Operating Agreement**

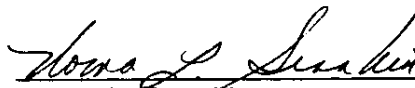
