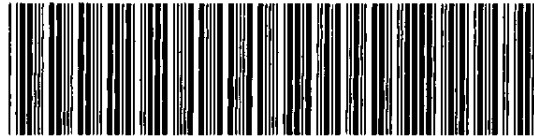

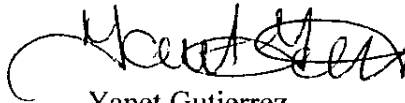

**ARTICLES OF ORGANIZATION  
OF  
IN TOUCH HOLDINGS LLC**

**ARTICLE I  
Name**

The name of the limited liability company is In Touch Holdings LLC (hereinafter called the "Company").

**ARTICLE II  
Duration**

The existence of the Company shall be perpetual.

**ARTICLE III  
Principal Office**

The mailing address and the street address of the principal office of the Company is 2750 N.E. 185<sup>th</sup> Street, Suite 306, Aventura, Florida 33180

**ARTICLE IV  
Initial Registered Office and Registered Agent**

**ARTICLE V  
Restrictions on Membership and

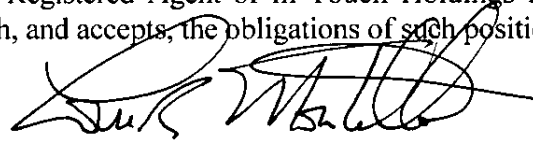
