ARTICLES OF ORGANIZATION for EAGLE TITLE AGENCY OF JACKSONVILLE, LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Eagle Title Agency of Jacksonville, LLC ("Company").

ARTICLE II - STREET ADDRESS

The street address of the principal office of the Company shall be 8137 Suffield Court, Jacksonville, Florida 32256.

ARTICLE III - MAILING ADDRESS

ARTICLE IV - DURATION

The Company is to exist perpetually.

ARTICLE V - PURPOSES AND POWERS
