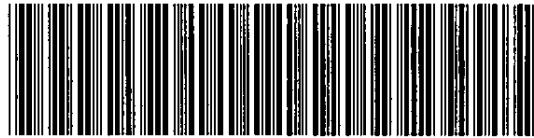


ARTICLE IX
