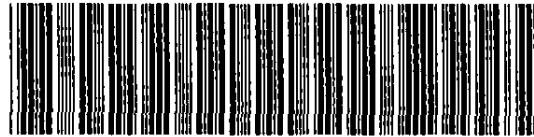

The name of the Company is Linear RX, LLC.






