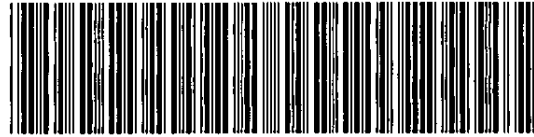

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned, being authorized to execute and file these Articles of Amendment to its Articles of Organization for the above Limited Liability Company, hereby certifies the following:

**FIRST:** The original Articles of Organization were filed on October 13, 2008 and assigned Document No. L08000096518.

**SECOND:** Article I of the Articles of Organization is hereby amended to read as follows:

**ARTICLE I - Name:**


The name of the Limited Liability Company is Canady and Jagdeo Physician Associates, LLC.
