The undersigned, being an authorized representative of the Member and Managers of the Company, in lieu of a special meeting, adopts the following resolutions amending the Articles of Organization:

RESOLVED, that Article 1 of the Articles of Organization filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:
