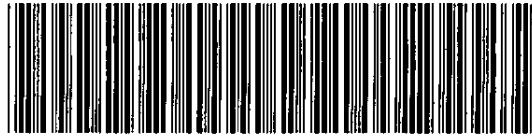

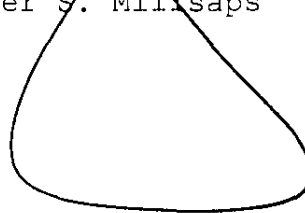


Article VII

in the Operating Agreement of the Company.


