**ARTICLES OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION OF
MGIC-SOUTH CAROLINA, LLC**

Pursuant to Section 608.411 of the Florida Statutes, **MGIC-SOUTH CAROLINA, LLC**, a Florida limited liability company, hereby adopts the following Articles of Amendment to its Articles of Organization:

ARTICLE I. NAME


The name of the limited liability company is **MGIC METROWEST, LLC**.
